The Oaks Equestrian Center First to receive 5-Star Rating and Seal of Sustainability

In early 2008 the O'Connor Signature at the Oaks Equestrian Center joined as a pilot member of the Audubon Lifestyles Sustainable Equestrian Facility Program, a voluntary program that is setting the standard for sustainably-managed equestrian facilities. The facility was recently recognized by Audubon Lifestyles as the epitome of sustainability by receiving a Five-Star rating. In doing so the O'Connor Signature at the Oaks Equestrian Center became the first equestrian facility in the world to receive the designation. In addition to receiving the Five-Star rating from Audubon Lifestyles, the O'Connor Signature at the Oaks Equestrian Center has also been issued the Seal of Sustainability from the International Sustainability Council (ISC).

The Oaks is a project of Dicks Realty which is located in Lake City, Florida, in the triangle between Ocala, Jacksonville and Tallahassee. The planned neighborhood development has over 1,200 rolling acres, filled with large, mature oak trees, and is located near the Osceola National Forest. The development includes more than 15 miles of looped riding trails, giving residents and property users the feeling of being in a wilderness. In addition, the cross-country course (custom designed by Olympian David O'Connor) and custom top-of-the-line 33-stall barn is complemented by a competition-quality outdoor ring, covered round pen, and a large covered arena. These features and more distinguish the O'Connor Signature at the Oaks Equestrian Center as a truly premier and one-of-akind equestrian facility.

Through these standards, equestrian facilities will be recognized for following design and operational parameters that promote all aspects of sustainability.

In addition to setting the standard for sustainably-managed equestrian facilities the Audubon Lifestyles Equestrian Facility Program was developed to offer achievable, yet comprehensive sustainable programming to equestrian managers and owners, and to reward facilities that do more, than the minimum through a series of recognition and branding opportunities. Not every facility will choose the path toward sustainability, but those that chose to participate will become the leaders in the industry.

Planning a Sustainable Franklin, Tennessee

In early June 2009, through a series of daylong charrettes culminating in a public meeting, Audubon Lifestyles assisted LandDesign, city stakeholders and the Steering Committee for Franklin, Tennessee to develop a plan that is intended to serve as a unified guide, and central coordinating mechanism for the future of Central Franklin that:

 emphasizes the interrelated nature of Central Franklin's diverse neighborhoods and its historic commercial core as a key to its long-term success and vitality;




- synthesizes and builds upon the previous work efforts and successes of the City, the stakeholders and numerous organizations already active in Central Franklin;
- complements the citywide recommendations of the Central Franklin Area Plan;
- focuses on broad issues as they pertain to all of Central Franklin, not just specific geographic areas within it; and
- perhaps most importantly, identifies the necessary "next steps" the community must take in order to achieve the implementation of its goals for Central Franklin.

The Central Franklin planning area encompasses nearly 4,000 of the City of Franklin's 18,726 acres and includes the downtown, or 15-Block Area, as well as many of the City's historic residential neighborhoods. The importance of the Central Franklin as the "core" of the community was recognized as most important, and the

character of Central Franklin is what was used as the model that should affect and influence the vision of the citywide plan, and upon which Franklin's future as a city should be based upon.

The Audubon Lifestyles team is proud to have been apart of this process, and is excited to continue to work with the City of Franklin, Tennessee as they move towards becoming more Sustainable.



The Importance of Openspace Planning

Growth and land conservation are often seen as two opposing forces—with proponents of each scrambling to beat the other to valuable land. Fortunately, a new paradigm is emerging.

Development and conservation of open space can be compatible and complementary when applied in strategic, collaborative ways.

Open Space is land that is not intensively developed for residential, commercial, industrial or institutional use. It serves many purposes, whether it is publicly or privately owned. It includes agricultural and forest land, undeveloped shorelines, undeveloped scenic lands, public parks and preserves. It also includes water bodies such as lakes and bays. What is defined as open space depends in part on its surroundings. A vacant lot, community garden or small marsh can be open space in a big city. A narrow corridor or pathway for walking or bicycling is open space even though it is surrounded by developed areas. Historic and archeological sites are often associated with significant open spaces and are a part of our common heritage.

Why Plan for open Space Conservation?

- An open space conservation plan can recommend new recreational facilities to enhance the economic as well as the social life of the community.
- It can recommend that a community enhance its downtown by planting shade trees and creating small sitting parks. It can protect wetlands, stream corridors and other ecologically important features.
- It can lead to the establishment of linkages between these areas and sites through greenways and bicycle trails.
